First, we already have two very successful specialty court programs—Drug Court and Mental Health Court. These programs address specific needs within our community, providing targeted support and rehabilitation opportunities. I propose adding a third specialty court: Veterans Court. This court would focus on veterans who, due to mental health issues or substance abuse problems, have found

themselves in legal trouble. With the collaboration of the state attorney and the defense bar, Veterans Court would ensure that our veterans receive the specialized attention and support they deserve, helping them reintegrate into society and reducing recidivism rates.

Secondly, I propose establishing a satellite court in the West End/Englewood area. Currently, residents from Englewood and the West End face long drives—often over an hour—to the courthouse in Punta Gorda. While our clerk already holds Englewood days, introducing regular court sessions in this area would significantly improve access to justice. By utilizing the existing annex building, we can make it more convenient for residents to appear before a judge without the burden of extensive travel. It is more practical and efficient for one judge, along with a clerk and bailiff, to travel to Englewood than for 50 people to make the trip to Punta Gorda. This initiative would not only save time and resources for the community but also ensure that justice is accessible to all, regardless of their location within the county.

In summary, by implementing these initiatives—Veterans Court and a satellite court in the West End/Englewood area, we can enhance access to justice, provide specialized support where it is needed most, and improve the overall efficiency of our judicial process in Charlotte County.
